The Arlington County Civic Federation will meet Tuesday,
December 2ND at 7:45 P.M. Meetings are held in the dining room of

Arlington County School Board and the Superintendent of Schools will
be featured guests. They will talk about the latest developments in
the public school system and respond to questions from the delegates.

Leaf Collection: Leaf collection began November 3RD, and will continue until late December. Crews operating 16 vacuum trucks will attempt to complete 3 passes through all 32 leaf collection routes in Arlington County. While exact pickup dates cannot be predicted due to the uncertainties of weather, rate of leaf fall, and equipment breakdown, an approximate idea of when crews will be in the neighborhood can be gotten by looking at the maps posted in all Libraries, Community and Recreation Centers, Human Resource Centers, and at the Court House. These maps, which are updated weekly, portray all collection routes and indicate where crews are currently working.

To assist in the collection effort, residents are requested to rake leaves to the curblines in clearly defined piles which are free of sticks,

stones, cans and other trash which could damage the vacuums.
