The Dangers of Rabies:

Even though your animals are protected by rabies shots, their exposure to rabid animals and your touching either the rabid animal or your pet could expose you to rabies. If there is any possibility of danger, ACT AT ONCE - get medical treatment to save your life.

DO NOT try to kill a rabid animal yourself. Call the animal

warden of Arlington County - 558-3120.

Control of Dogs:

Neighbors are concerned about dog control here, and have asked that certain considerations for one another be made.

1. Dogs should not be permitted to leave their evidence in the school areas where children play, as well in people's yards.

2. Unleashed dogs create hazards for people walking or walking their dogs.

The Arlington County regulation on leashing dogs is as follows:

Article 2, Section 2-6 of the animal and fowl code. LEASHING DOGS: ALL dogs shall be kept secured by a leash or lead and under control of the owner or other responsible person or within the real property limits of its owner. A waver to this requirement for a specific time and place may be obtained from the dog warden's office for such activities as off-lead training obedience matches and trials when the dog has a skin condition which would be ascerbated by the

wearing of a collar and other activities which promote animal control. Nothing in this section of the county code nor in any other section shall be deemed to make unlawful the exercising of dogs not upon a leash in areas of the county specifically designed for such exercises. Adopted 12/27/75 (amended 11/14/81).

For your information - SHOOTING IN ARLINGTON COUNTY -- the following regulation follows:

Section 17-5. FIREARMS AND MISSILES, DISCHARGING, THROWING. It should be unlawful for any person to discharge or shoot off in any part of the county within 100 yards of any public road, public building, private residence or property of another, any bean shooter, slingshot, bow or cross bow, or any rifle, pistol or shotgun, throwing or discharging missiles, arrows or bullets, by mechanical means or devices or by force of gun powder or other explosives.

Nothing in this section shall be construed to prohibit use of firearms or other instruments or missiles in self defense or in defense of property or to prohibit the use of firearms or other missiles in supervised sport, recreation or training conducted on safety-inspected and approved ranges, courses, provided the same is not contrary to existing law. Adopted 7/14/1924.
